The research is finalised by the defense of the PhD thesis. The Graduate School in Philology promotes the development of excellence in fundamental and applied research meant to improve the standards of higher education by the promotion of interdisciplinary research partnerships and activity at both national and international levels, given the pronounced interdisciplinary nature of research in both fields of the graduate school, and the transversal competences.
